

LSV Asset Management Launches New Emerging Markets Equity Fund

Chicago, Illinois - LSV Asset Management (“LSV”) is pleased to announce an expansion to the LSV mutual fund family with the launch of a new mutual fund: LSV Emerging Markets Equity Fund (Investor Share Class: LVAZX, Institutional Share Class: LSVZX).

“We believe that with the launch of this Fund, we’re bringing a unique product to the market that gives investors exposure to companies we feel are undervalued across many industries and countries within the emerging markets asset class,” said David Coon, Director, Retail Sales and Services at LSV. “LSV has been managing emerging market equity assets for 14 years and we’re excited to offer retail investors a vehicle to access an asset class which has historically generally been reserved for institutional investors.”

The LSV Emerging Markets Value Equity fund seeks long-term growth of capital. Security selection focuses on companies whose securities seem out of favor in the marketplace but have shown signs of recent improvement. LSV uses a quantitative investment model that ranks securities based on fundamental measures of value (i.e. price to earnings ratio) and indicators of near-term appreciation potential (i.e. recent price appreciation).

The Fund is managed using the same investment philosophy that LSV has implemented since its inception twenty five years ago, that long-term results may be achieved by systematically exploiting judgmental biases and behavioral weaknesses that influence investors’ decisions. These include the tendency to extrapolate the past too far into the future, wrongly equating a good company with a good investment, irrespective of price, ignoring statistical evidence, and developing a “mindset” about a company. Investors in the Fund could potentially benefit from the same quantitative model and research driven investment process implemented across LSV.

The minimum investment for the investor share class is \$1,000 and the minimum investment for the institutional share class is \$100,000.
