The LSV Global Managed Volatility Fund (the “Fund”) applies the LSV quantitative model to a universe of stocks to create and maintain a broadly diversified portfolio of primarily large and mid-cap U.S., developed market non U.S., and emerging market non U.S. listed equities. The Fund aims for deep value orientation relative to the Fund benchmark, including low price to earnings, low price to cash flow, and high dividend yield relative to the Fund benchmark. The Fund also aims to manage volatility by selecting stocks whose total returns are expected to fluctuate less than those of the equity markets as a whole.

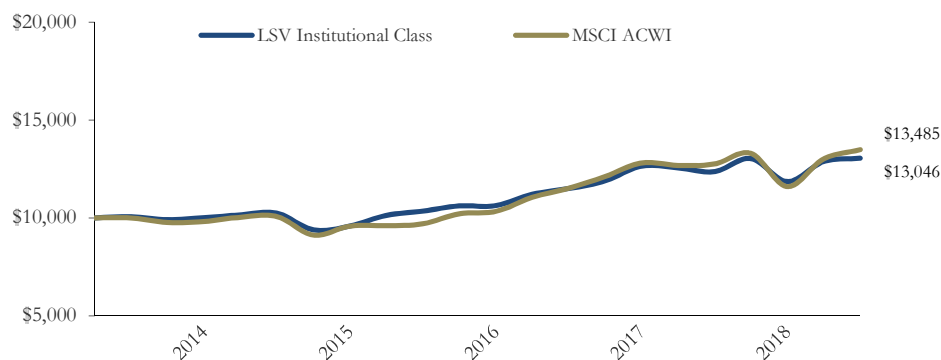

The LSV Global Managed Volatility Fund's investment objective is long-term growth of capital with a lower level of volatility than the Fund benchmark.

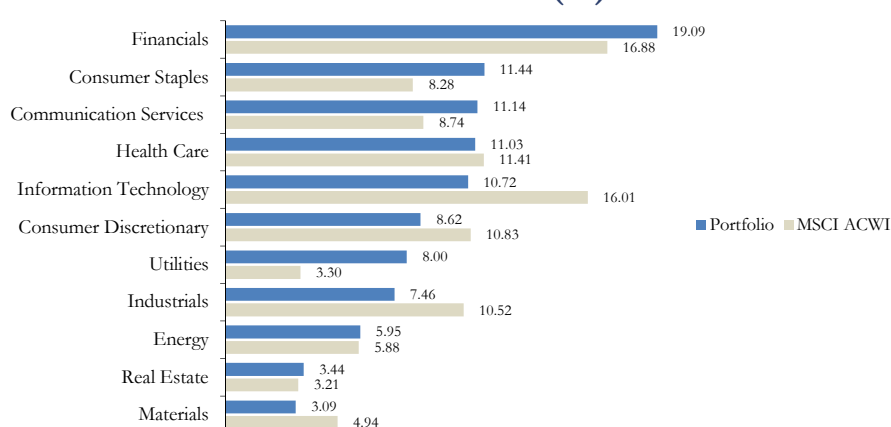
Who Should Invest

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The Morningstar Rating does not include any adjustment for sales loads. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. As of June 30, 2019, LSV Global Managed Volatility Fund (LSVFX, LVAFX) was rated against 722 U.S.-domiciled World Large Stock funds over a 3 year period and 594 funds over a five year period. With respect to these World Large Stock funds, both LSVFX and LVAFX received a Morningstar Rating of 2 stars for the three year period and 3 stars for the five year period.
