

The Morningstar Rating TM for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. As of September 30, 2025, LSV Small Cap Value Fund (LSVQX, LVAQX) was rated against 462 U.S.-domiciled Small Value funds over a three-year period, 434 funds over a five-year period, and 360 funds over a ten-year period. With respect to these Small Value funds, LSVQX received ratings of 4 stars over three years, 4 stars over five years, and 2 stars over ten years, while LVAQX received ratings of 3 stars over three years, 4 stars over three years, 4 stars over ten years.

The Morningstar Medalist RatingTM is the summary expression of Morningstar's forward-looking analysis of investment strategies as offered via specific vehicles using a rating scale of Gold, Silver, Bronze, Neutral, and Negative. The Medalist Ratings indicate which investments Morningstar believes are likely to outperform a relevant index or peer group average on a risk-adjusted basis over time.
