

It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. With respect to these Small Value funds, the funds received a Morningstar Rating of 2 stars for the three year period and 3 stars for the five year period.
