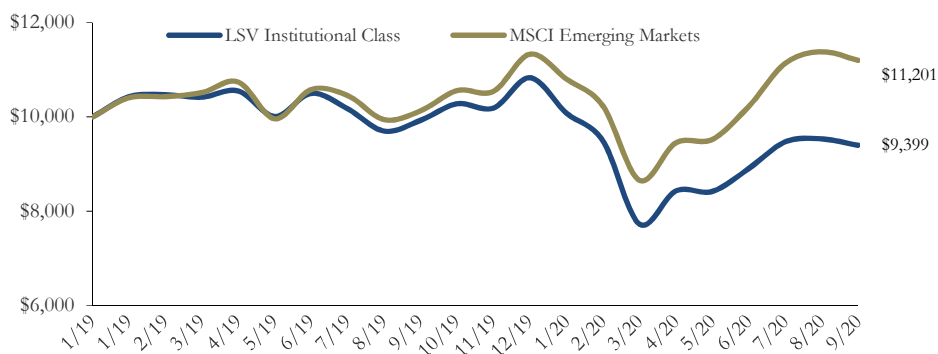

The LSV Emerging Markets Equity Fund's investment objective is long-term growth of capital.

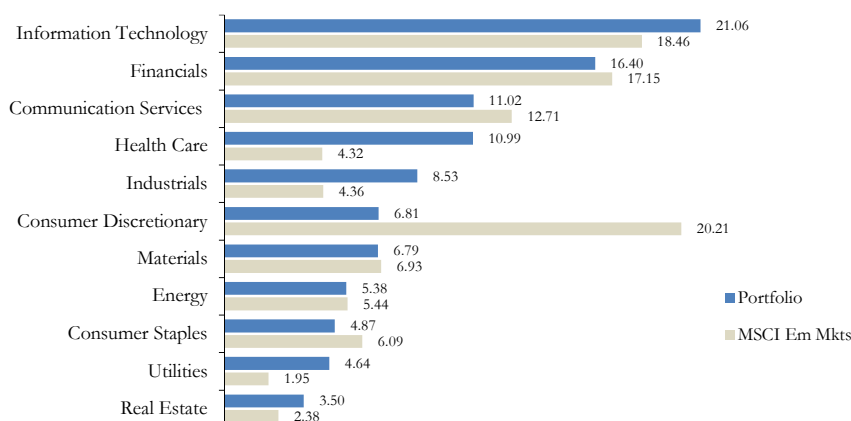
Who Should Invest
